#### RECOMMENDATION RE EARTHWORKER

**COPY OF EMAIL – 15/4/2000 from Earthworker to Premier Bracks**

Dear Mr Bracks,

Earthworker is saddened to see yet more allegations of violence against forest activists in Victoria's forests. That the weekend confrontation occurred so soon after the signing of the Regional Forest Agreement is evidence of the failure of the RFA process to address the widening divisions in our rural communities.

The criticisms made by environmental organisations of the Department are well known and do not need re-stating here. Given that logging contractors involved in the latest incident claim to have received no help from the Department of Natural Resources and Environment to retrieve their equipment, leading them to take matters into their own hands, it is clear that the Department is not playing a constructive role for any of the parties.

The essence of the matter is that the Department is mis-managing Victoria's forests and thus creating frustrations and tensions between loggers and forest activists. The continuing confrontations between loggers and activists are a direct result of this mis-management.

The government must take responsibility for the actions of its departments. It appears that the Minister in this case is unprepared or unable to ensure that her department engages in the process of establishing an environmentally-sustainable (and thus economically-sustainable) timber industry. She also appears to have been reluctant to try to break the cycle of confrontation that is relegating any constructive debate on forest policy to secondary status. The issue of forest management is one that will continue to provide the government with bad publicity, especially so long as violent incidents continue to occur.

It is imperative now that the government intervenes to prevent the further escalation of violence. You must establish a consultation process involving all parties with an interest in Victoria's forests. This does not mean a few representatives of the big timber companies plus a union leader or two and the spokesperson of an environmental organisation. Every effort must be made to involve those people who are at the front line of confrontation: forest activists, local residents and timber workers themselves. An independent inquiry into the violence, with a brief to suggest ways of avoiding it in future, is also a necessity.

For too long the process of forest management has been a matter of secretive negotiations between departmental bureaucrats and the representatives of foreign woodchip companies. It is time now to involve the people for whom the forests mean much more than just shareholder dividends.
